<b>KEY CITY DEVELOPMENT ISSUES</b>		<p>Palembang is not only the center of governance but also the center of trade, industry, and tourism on the island.</p> 	
<p>The Strategi Pengembangan Permukiman dan Infrastruktur Perkotaan (SPPIP) produced by the Department of Public Works (DPW) sets out the overall development strategy for Palembang. Consistent with the Rencana Tata Ruang Wilayah (RTRW – Land Use Plan), the goal is to achieve Palembang BARI – Bersih, Aman, Rapi dan Indah (Clean, Safe, Orderly and Beautiful). Concerning the Project Study Area, DPW Decree 63/PRT/1993 specifies a protected corridor of 15 m on both banks of the Musi River. Land rehabilitation is called for along the entire length of the river corridor together with drainage, wastewater and solid waste management improvements plus flood protection and commercial development.</p>
