One important factor in the development of the local economy is through the development of traditional markets. However, traditional markets in Semarang are in bad physical and environmental condition. The City government has previously commissioned several studies regarding the revitalization of Pasar Johar, the key central traditional market, including a Feasibility Study and Urban Design Guideline of Johar area. However, technical, financial and social challenges prevented the city from moving forward and implement the project.</p>
